APPLICATION FOR ACTIVE MEMBERSHIP

**MEMBERSHIP YEAR:** The membership year begins on January 1.

**ANNUAL DUES:** \$2,000 per year.

**AGCI PAC:** \$1200 of Annual Dues is earmarked for AGCI PAC. Any member objecting to Annual Dues earmarked for AGCI PAC may direct in writing that such sums be used only for general revenue purposes.

**ASSESSMENTS:** AGCI has moved from an assessment-based system to an IAF-based system. AGCI will cease assessments after the March 2019 IDOT letting in most counties.

For work in counties that all trades fall under an AGCI negotiated collective bargaining agreement the IAF rate will be \$0.20 per all hours worked for all trades. In southern Illinois, laborers' locals 773/1197, operators local 318 have an IAF rate of \$0.16 per all hours worked. There will be no assessments.

For work in counties that no trades fall under an AGCI negotiated collective bargaining agreement, Active Members will be billed for assessable work put under contract based on the following formula: .0030 for work up to \$4,000,000; plus .0005 for cumulative work \$4,000,001 up to \$60,000,000.

For work in counties where not all trades fall under an AGCI negotiated collective bargaining agreement, there will be a blended system.

**ASSESSABLE WORK:** Assessable work is defined as all highway, heavy and utility construction and maintenance work awarded by a public agency in Illinois and performed in the State of Illinois with the exception of federally funded flood control and navigation work on the levees, banks and channels of the Mississippi River, heavy work in Cook, Madison, Monroe, and St. Clair Counties, and utility work in Cook County.

**BARGAINING RIGHTS:** A voluntary Assignment of Bargaining Rights Form should accompany this Membership Application.
