**APPLICATION FOR ACTIVE MEMBERSHIP  
(DOWNSTATE CONTRACTORS)**

**ONE-TIME ENROLLMENT FEE:** New **Active Members** are charged a one-time fee of \$50 to cover enrollment costs.

**MEMBERSHIP YEAR:** The membership year begins on January 1.

**ANNUAL DUES:** First-year Annual Dues will be \$1,475.00 which includes \$50 initiation fee (first-time members only) automatic enrollment in AGC of America, and funds earmarked for AGCI PAC and AGC of Illinois general funds). Annual Dues in following years will range from a minimum of \$1,425.00 to a maximum of \$5,550.00 based on the volume of assessable work for the previous calendar year.

**AGCI PAC:** A portion of Annual Dues is earmarked for AGCI PAC. In the first year that sum is \$450. In the following years the portion earmarked for AGCI PAC is a graduated sum from \$450 to \$900, based on the volume of Assessable Work for the previous calendar year. Any member objecting to Annual Dues earmarked for AGCI PAC may direct in writing that such sums be used only for general revenue purposes.

**ASSESSMENTS:** Active Members will be billed for assessable work put under contract based on the following formula: .0030 for work up to \$4,000,000; plus .0005 for cumulative work \$4,000,001 up to \$60,000,000. Maximum annual assessment is \$40,000. Minimum annual assessment is \$1,000 billed with annual dues each year to Active Members. Assessments are payable within 30 days of being invoiced.

**ASSESSABLE WORK:** Assessable work is defined as all highway, heavy and utility construction and maintenance work awarded by a public agency in Illinois and performed in the State of Illinois with the exception of federally funded flood control and navigation work on the levees, banks and channels of the Mississippi River, heavy work in Cook, Madison, Monroe, and St. Clair Counties, and utility work in Cook County.

**MEMBERSHIP CAMPAIGN:**

Beginning January 2, 2015 the AGCI Membership Committee, with the approval of the Board of Directors, will begin a three-year membership campaign. Reductions in dues and assessments will be as follows:

Active member dues - \$1,350 annually  
Specialty Contractor dues - \$1,000 annually

1<sup>st</sup> Year – Assessments will be invoiced at one-third the normal rate as listed above.

2<sup>nd</sup> Year – Assessments will be invoiced at 2/3 the normal rate as listed above

3<sup>rd</sup> Year – Assessments will be invoiced at the normal rate as listed above.
