- 2) Pension Fund payments to be sent to Central Laborers' Pension Fund Office, P.O. Box 1267, Jacksonville, Illinois 62651.
- 3) Overtime hours worked to be paid at the applicable overtime rate.
- 4) Overtime hours for Annuity will be paid at the applicable overtime rate and sent to Central Laborers' Fringe Benefit Funds, P.O. Box 1267, Jacksonville, Illinois 62651.
- 5) \*Laborers'-Employers' Cooperation and Education Trust (L.E.C.E.T.), nineteen cents (\$.19) to be paid by the employer. Employers that perform work on windfarms and pipelines shall pay a L.E.C.E.T. contribution of \$0.29 per hour.

- 6) Employers that perform work in the Hazardous Waste, Asbestos and Lead Base Paint Industries shall pay a training program contribution of \$.10 per hour above the training program contribution as referred to above.
- 7) The Associated General Contractors Industry Advancement Fund (IAF) contributions are above the basic labor rate and shall be sent to the Central Laborers' Pension, Welfare and Annuity Fund Office, P.O. Box 1267, Jacksonville, IL 62651.
- 8) \*\*Dues Check-Off calculated as a percentage of gross pay.
- 7) Dues Check-Off and Market Preservation Fund to be deducted from the Basic Labor Rate.
- 8) Vacation Fund: Overtime hours to be paid at the applicable overtime rate.
- 9) Welfare Fund Contributions: Welfare contributions for overtime hours worked to be paid at the straight time rate.
